

Sub: Non-compliance under the provisions of Water (Prevention & Control of Pollution) Act, 1974 in respect of your apartment by name Off. Sarjapura Outer Ring Road, Bellandur Village, Bengaluru - 560 103-reg.

Ref: 1. Consent issued by this office vide No. KSPCB/RO-BNG EAST-2/Reg.No. 19870/2010-11/R-696, dated 19.05.2010

2. Inspection of your apartment by the Deputy Environmental Officer of this office on 28.03.2011.

Adverting to the above subject, it is to be informed that your apartment was inspected by the Deputy Environmental Officer of this office on 28.03.2011 and following were the observations:

- 1. The STP units provided are not functioning properly.
- 2. You have not installed Flow meter and separate energy meter for STP.
- 3. You are not recording the quantity of effluent treated in STP logbooks and not maintained logbook properly.
- 4. You have not provided water meter and not filing cess returns as per Water Cess Act.
- 5. You have not provided Organic Converter, rain water harvesting facility, dual pipeline for reusing treated effluent for toilet flushing.
- 6. The entire garbage is being handed over to BBMP without segregation and even STP sludge is also being handing over to outside party illegally.
- 7. Provided the storm water pipe line from apartment to Bellandur Tank without the permission of the
- 8. You are discharging open area runoff water, road washings, vehicle washings and excess treated effluent to Bellandur Tank by violating the provisions of Water Act.
- 9. You have not submitted the Environmental Statement in Form-V for the year 2009-10.
- 10. Not replied to any notices issued by the Board.

The Senior Environmental Officer has inspected your apartment on 04.03.2009 and noticed permanent pipeline provided for the discharge of excess treated sewage into Bellandur Tank from your apartment and issued a show cause notice on 24.03.2009. But, so far you have not replied.

- The above observations clearly indicate that you are not operating the STP units properly and not complied with the conditions stipulated in consent issued vide ref (1). It is apprehended that the discharge of untreated effluent from your apartment to Bellandur tank will deteriorate the quality of lake and affects the flora and fauna of the lake.

In view of the above non compliance, you are hereby informed to submit the action plan within 7 days and also called upon to SHOW CAUSE within in 7 (seven) days from the date of receipt of this notice, as to why this office shall not initiate action against your

apartment, which includes filing of criminal case against you before the Judicial Magistrate Court and also to invoke 33(A) of Water (Prevention & Control of Pollution) Act, 1974 and to direct you to close the apartment, BWSSB to stop water supply and Electricity Supply Company to cut off power supply. If no reply is received within the prescribed time then it is construed that you have nothing to say in this matter and this office will proceed with the aforesaid actions without further hearing from your end and the consent issued vide ref(1) will be WITHDRAWN as per the provisions of the Acts..
